PROMOTING CHILDREN'S BEHAVIORAL HEALTH THROUGH SYSTEMS CHANGE











- Texas is home to more than 7 million children live in Texas, representing nearly 1 in 10 children living in the U.S.
- Fifty percent of Texas kids are Hispanic/Latino, 33 percent White, 11 percent Black, and 6 percent Asian, multiracial or some other race.













- Texas ranks 41st in child wellbeing
- Texas ranks 49th in per capita spending for mental health.
- In 2011, the state legislature cut public education funding by
 5.3 billion dollars









- In Texas, 600,000 children, youth, and their families experience behavioral health needs before the age of 18.
- Only 26% receive treatment.
- The largest provider of mental health services for youth in the greater Houston area is Juvenile Probation. Fully 71% of all youth referred to the system have an identifiable mental health diagnosis.
- Between 1999 and 2009, 9 out of 10 students classified as having an emotional disturbance in a Texas public school were suspended or expelled from school for discretionary reasons.









- In the Houston Independent School District, where almost 90% of the students are minority and 75% economically disadvantaged, there are 1,175 students for every counselor.
- Meanwhile, the Texas district has one security staffer for every 785 students.







But that's not the worst of it . . .



A recent investigative report by the **Houston Chronicle (October, 2016)** determined that in 2004, the Texas **Education Agency (TEA) instituted an** artificial 8.5% cap for special education identification, resulting in the denial of services to thousands of students experiencing mental health concerns over the past 12 years.







There is good news, too!

Senate Bill 460

SB 460 (Sen. Deuell/Rep. Coleman) requires that:

- Individuals in educator preparation programs receive training in the detection of students with mental or emotional disorders in order to receive their teaching certificate
- School districts to provide mental health training for current junior high & high school teachers, counselors, principals & other appropriate administrators; to the extent funds and programs are available, requires school districts to provide mental health training to elementary school teachers, counselors, principals & other appropriate administrators
- Local school health advisory committees make recommendations regarding policies, procedures, strategies, & curriculum to prevent mental health concerns among students









Final Budget

SB 1 includes:

- 2018-2019: \$217 billion
 - Total General Revenue spending: \$107.8 billion approximately the same amount as the 2016-2017 budget (\$108 billion). This fell within the parameters of the Controller's BRE.
 - The final deal:
 - Defers \$1.8 billion of Prop 7 funds until FY
 2020 <u>allowing \$1.8 billion to be counted</u>
 <u>as General Revenue available in 2018-2019.</u>
 - Draws down less than \$1 billion from the \$10 billion Rainy Day Fund to be used almost entirely for state facilities repairs, construction and equipment purchases.


- Behavioral Health Funding:
- \$160 million added for various community-based services and projects
- \$35 million increase approved for state hospital operations, and
- \$300 million from the Rainy Day Fund to be used for state hospital repairs and construction -- "HHSC shall develop a comprehensive inpatient mental health plan for the replacement or significant repair of state hospitals or other state-funded inpatient mental health facilities to expand inpatient mental health capacity over the next three biennia."



House Select Committee on Mental Health: Opportunities to Solve Existing Service Gaps

- Prioritizing early intervention and prevention measures especially among school age children
- Expanding innovative public school-based programs
- Sustainability of the 1115 Transformation Waiver / DSRIP funded programs
- Expanding bed capacity by expanding step-down beds to provide a continuum of care
 - Part of this is expanding jail diversion programs for nonviolent offenders
- Continuing to address mental health workforce shortages through educational incentives and by expanding the availability and utilization of technology, such as telemedicine
 - Truly integrating healthcare to treat the whole person-physically & mentally
 - Rep. Four Price (R- Amarillo) understands issues related to IHC. Questions remain among the committee surrounding the implementation.

CSBH: Legislative Priorities

- Amend SB 460 to:
- Provide accountability measures to reinforce the training mandate through reporting through TEA
- Require all school personnel to receive training in how to recognize and appropriately respond to signs of trauma
- Make available at least one licensed behavioral health professional on each campus, as funding allows
- Require a transition plan for students returning from prolonged placement in out-of-school facilities, including disciplinary programs and residential treatment facilities

Great news from Austin

Last Friday, March 10 marked the deadline to file legislation for Texas' 85th legislative session. Mental Health America of Greater Houston is excited to report on the progress of our priorities.

I am excited to share that MHA of Greater Houston has successfully filed four bills, supporting both our Center for School Behavioral Health and Women's Mental Health programs.
We have also worked closely with Chairman Four Price and Representative Sarah Davis to ensure specific language reflecting our priorities was inserted into their existing bills concerning these legislative issues. We are proud of both the final bills resulting from these ongoing conversations and of the influence MHA of Greater Houston demonstrated during a critical moment when competing political priorities can too often sink impactful legislation.

Now that our bills have been filed, the next step is getting them through their respective committees. (More great news: HB 2135, our Post-Partum Depression bill, and HB 11, Chairman Four Price's children's mental health bill, have already been referred to the House committee on Public Health! Representative Davis' bill should be referred any day!)

After meeting with many members of the Houston delegation, we believe that our legislative agenda is strong; however, the current fiscal outlook and political climate in Austin make the passage of any bill a very difficult task. We have our work cut out for us during the next 73 days.


- Direct engagement of the State House of Representatives regarding MH / BH landscape
